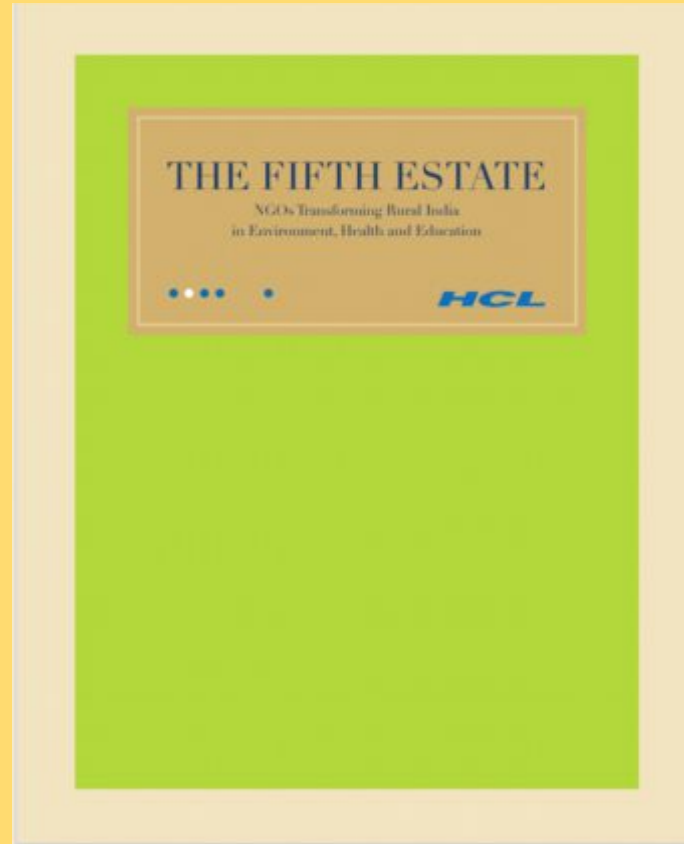

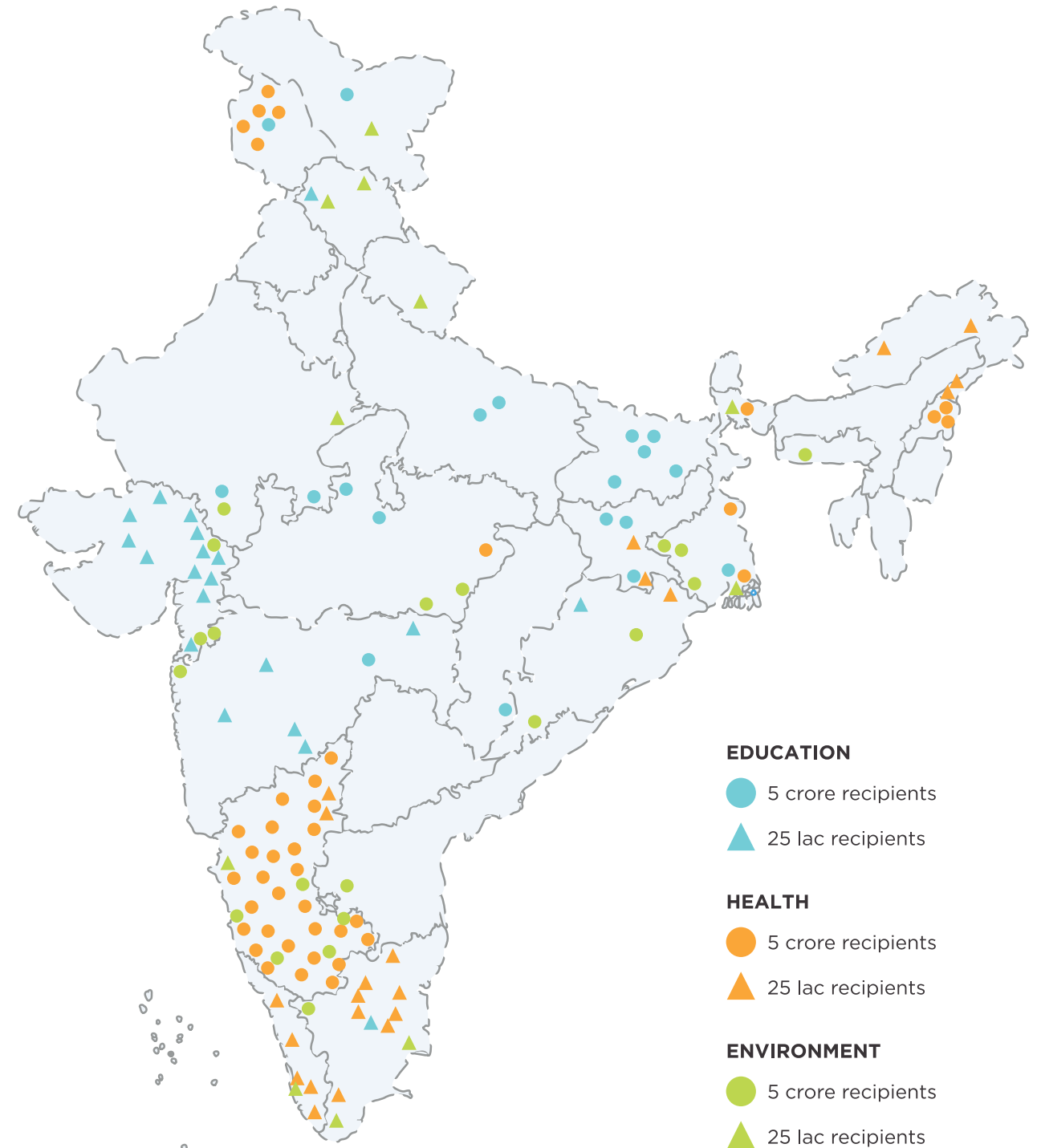

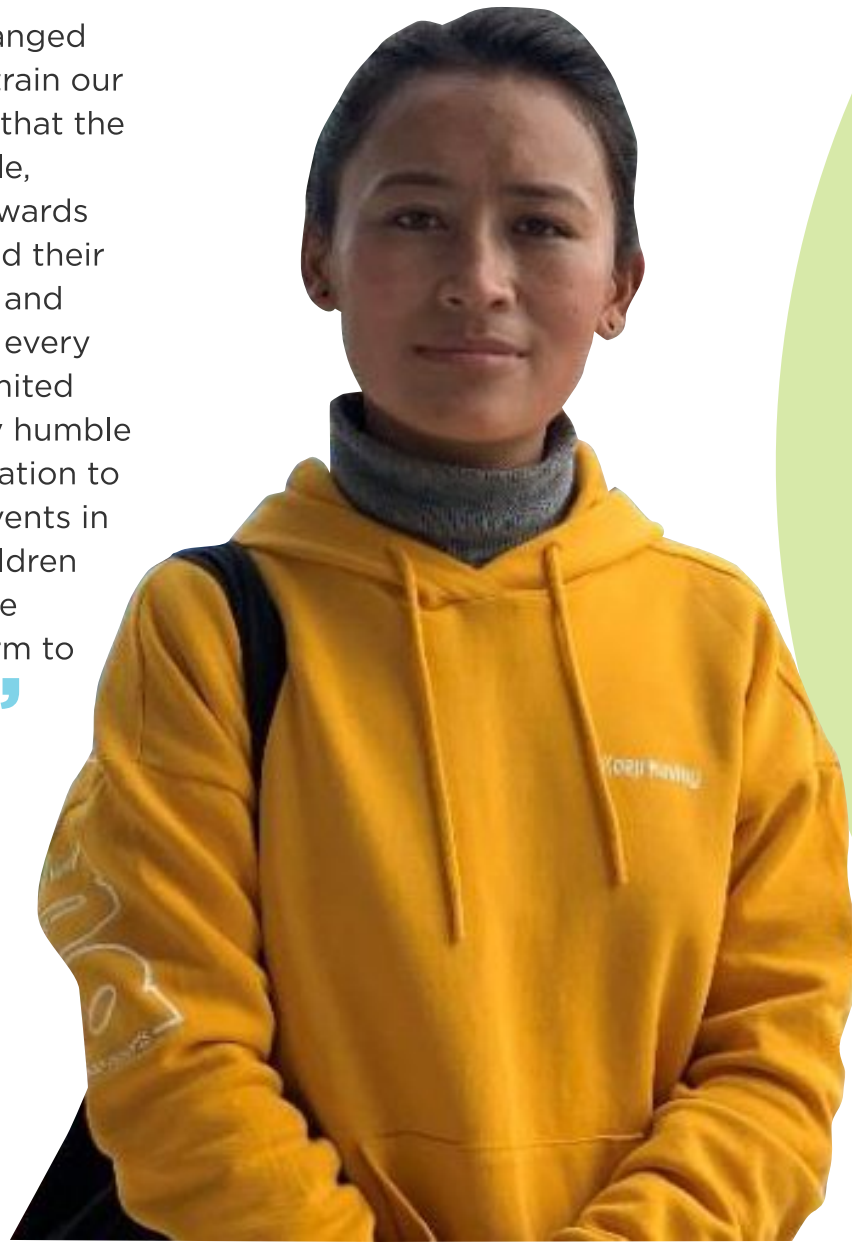

HCL Grant Virtual Partners Meet 2021

HCL Grant Virtual Partners Meet 2021 was conducted on November 23, 2021 for organisations associated with HCL Grant under thematic category of Environment, Health and Education to share their vision, ethos and strategies towards socio-economic development that have substantially contributed to nation building through effective CSR.

Back ground of the project

- Girl children from Bedia community are at multiple risk and vulnerabilities as the community is engaged in commercial sex as primary source of livelihood
- Bedia community was historically considered to be criminal, nomadic-tribe, which have now been included amongst the diversified nomadic-tribes
- Girls in the age group of 10-15 years are most susceptible to be pushed into commercial sex by family, thus being denied of education
- The stigma of their nature of work and criminal history has been allowed mainstream population to accept them

The project intends to bring social transformation in the community to break the cycle of historical stigma and deprivation of Bedia girls through education.

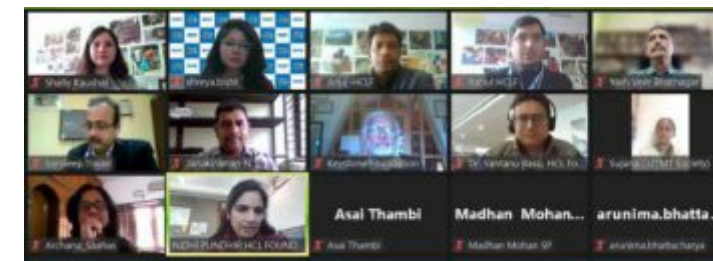

Stories of Transformation: Reaching the Unreached

Lighting up lives!

In the twenty-first century, certain areas in the country still lack access to power. One of them is Halwa Ambeng, Bolchugre, and Dambuk Atong village in Meghalaya's South Garo Hills. A total of 79 households from three villages (Halwa Ambeng-36 HH, Bolchugre - 14 HH, and Dambuk Atong - 29 HH) have been

provided with home solar lighting systems as part of the community intervention exercise under the HCL Grant project "Connecting landscapes, Empowering people, and Protecting elephant - An initiative to secure the Baghmara - Balpakram elephant corridor and protect the wildlife habitats of the Garo hills, Meghalaya."



Saahas

Evolving today to make tomorrow better

People in Dakshina Kannada district of Karnataka have protested due to misinformation about the Resource Recovery Facility (RRF) as a landfill site and other negative consequences. With over 40 people protesting, it seemed difficult to move forward with the formation of Jigani RRF and Karkala RRF. An intervention under the Paripurna project of HCL Grant, where team Saahas sensitized the locals about difference between a landfill site and RRF, not only eliminated people's fears, but also put a stop to the protest, creating a positive environment in the community

and allowing the work on establishment of both of these RRFs to proceed forward. Kushal Kumar, a member from Yedapadavu Gram Panchayat says, "Initially we had thought a new landfill site is being constructed for dumping waste for all Panchayats, so we protested. After team Saahas sensitized us about the project explaining us about what is MRF and how it will be beneficial for us by creating job opportunities for locals and also after visiting Udupi MRF and witnessing that there was no foul smell in the unit, we were convinced with this project."





She Hope Society for Women Entrepreneur

Beacon of Hope!

Hailing from a poor family with no means of income as her father has expired long ago, Mubeena-a case of Post-Polio Residual Paralysis (PPRP)- was psychologically down in dumps when Hope Disability Centre's one of the community workers identified her in 2020.

Despite economic hardships and physical disability Mubeena was passionate about her studies, but the thoughts of dropping out of her studies would often cross her mind.

Without a father and her mother having suffered from a stroke, supporting five sisters can be daunting and distressing without any regular means of income and a deformity on top of it can be taxing psychologically. It can tell upon the mental strength of anyone when she has to shoulder so many responsibilities alone.



It would need endless sessions of counselling for She Hope team to keep her morale up.

Upon assessment, Mubeena was found to be suffering from right leg PPRP with shortening of limb. At that time, she was going through a mental turmoil due to economic crisis in the family and her deformity also led to numerous challenges for her to carry out day to day activities. Team spent extended hours of counselling sessions with Mubeena to help her to get out of the mental rut that she was in and persuaded her to keep her studies ongoing.

A rehabilitation plan was simultaneously put in place in accordance with the protocols followed by the organisation. Her initial exercise plan was initiated to build her range of joints and strength of muscles.

She was also provided walking aids at regular intervals by Hope Disability Centre(HDC) to

augment her accessibility.

Despite challenges galore, she has gone on to complete her graduation and is currently doing her Masters in English. It is an achievement in the face of difficulties that life has been throwing her invariably.

She continues to receive support from HDC along psycho social counselling.





Eleutheros Christian Society

Healthy mother for a healthy child!

Thaonyu, thirty-three-year-old is the resident of Tamkoang village, Nagaland. She has four children - a girl and three boys. Before the intervention of Eleutheros Christian Society under its HCL Grant project in the village, she was not aware of any of the health issues that are there related to women and children. But after ECS came in, she slowly started learning about the importance of health particularly on pregnancy and child care. With the help of the health workers, she went and did ANC check-ups during her pregnancies. After the deliveries, she enrolled all her children under immunization. Her husband Changkhao says, “ We are thankful to ECS for providing nutritional supplements during the lock down period last year. Thaonyu was severely anemic with a hb

count of only 5.9 g/dl. With the help of regular counselling and nutritional support through ECS, her hb improved to 12.9 g/dl.”



Child Rights & You

Beating the odds!

Beating the odds is almost synonymous with this one! Defying societal norms, Palak (Name Changed) went ahead to re-start her journey of learning after a gap of 3 years; she is persistent in her pursuit. In her village Korasa, it's not easy for girls to pursue education - they're either told to learn household chores or are trained by women in commercial sex to join the traditional occupation. In a Bedia village, the fate of a girl is decided by her family based on their economic condition, once she attains puberty.

Child Rights and You (CRY) with the support of HCL Foundation started working in the village Korasa in June 2021. It is a small village situated 65 km from district Headquarters Sagar. CRY started its work in Korasa with the

Establishing Child Activity Center(CAC) and adolescent girls group that aims to empower children in villages with wings of knowledge and transform them into agents of change within their immediate realities of the village and community life.



The adolescent group was conceived to address a variety of concerns of adolescents in the project village. The adolescent group provides children a platform where they can voice their opinions and express themselves. Through these groups, CRY ensure a conducive and nurturing environment for our children in the villages. Adolescents' groups provide an alternate path to vulnerable children through Life skills Module (Child Center). These groups also help in creating a support system for each child in the form of peers. Prior to the formalization of

adolescent groups in the village Korasa, special focus is given to enrolling the girls who were identified as vulnerable to enter into commercial sex industries. Palak, an 8th standard drop-out since 2018 was listed as one of the vulnerable girls among 14 other girls in Korasa. She became a part of the CRY adolescent group. Being in a nurturing environment where conversation related to identity, individuality, and decision-making talks happened through games and role-playing. She grew in confident and decided to stand for herself.

Palak's elder sister is active in the commercial sex industry and the only bread earner for the family of five members. Palak's father like the rest of the Bedia males does not contribute much in the family income and the mother does the household work. Palak was under constant pressure from the family to join the commercial sex to supplement the family earnings as her elder sister is earning less now due to having a child and aging in the commercial sex industry. Palak who had only two choices like other girls of her age opted for a road that is less travelled by the girls of her age. Confident Palak,

stand up to her parents when they started to force her to start working in the commercial sex industry to earn for the family and denied to bow down and joined the CAC and reinitiate her education.

She is now more determined to do well in her life - not only for her family but for the entire Bedia community! Palak's stand for self has become an inspiration for other girls in the community to resume their lives by exploring more options than the two imposed by the community upon them!

Krida Vikas Sanstha

Goal!

Isha Sillare, 18 years old, comes from a humble background. She has 5 members in her family. Being her father the only breadwinner made it difficult for her to continue her education. She didn't even have enough money to buy bags and books making it difficult for her to continue her education. But when Krida Vikas Sanstha supported her financial aid she got the chance to not only complete her education but also enrolled herself in college and now pursuing BSc in Mathematics from Hislop College Nagpur.

Isha started playing football in 2017. With her dedication and perseverance, she achieved a milestone which no one has ever been achieved in her family nor in her community. She played Schools Division State Tournament in Aurangabad and became the top scorer. Later, she went on to play Schools Division

National Tournament in Odisha and Andhra Pradesh in 2018, and 2019 respectively. Not just that, she has also been an excellent student in academic as well. Passing with more than 90% in 10th and 88% in 12th she has become a perfect example.

She was initially denied to play football just because she is a girl, but today her family is proud of her of what she has achieved in sports and education.

She is now engaging more than 60 girls in 2 different villages. Having experience, the power of football, she wants to provide this opportunity to other girls in her village and around, to come forward and achieve their dreams. The community she belongs to is so conservative and patriarchal that girls are supposed to do household chores, and sports are considered a taboo.

UDAAN - Breaking Barriers and Rebuilding Lives
Indore: The income of Bedia families in Madhya Pradesh, whose women rely on sex labor, is largely dependent on outsiders. The outbreak of COVID-19 and the lockdown restricted the movement of individuals due to fear of transmission, which had a direct impact on the family income. The communities were forced to take out high-interest loans from private money lenders, which had a long-term impact on the families' economic sustainability. Forced dropouts due to the closure of schools, lack of access to digital devices, and the responsibility of supporting in-home duties worsened the problem. Young girls' vulnerability to the commercial sex industry, as well as an increased rate of new girls entering the business after the first and second waves of the pandemic, was also observed. Child Rights & You (CRY), a non-profit organization working to ensure happier childhood for all children, has been running a project UDAAN - Breaking Barriers and Rebuilding the Lives of Bedia Girls in two districts of Madhya Pradesh. The project intends to bring social transformation to the community and to break the cycle of historical stigma and deprivation faced by Bedia girls through education. This project earned CRY the prestigious HCL Grant 2021 under the Education category. The organization received a grant of 15 crurs through HCL Grant, a CSR commitment by HCL through HCL Foundation, to implement the project in a more organized and accountable manner. One of the biggest and most coveted institutionalized CSR grants of India, HCL Grant recognizes the rise of community-led ecosystems of NGOs. As Ms. Nidhi Pundhir, Director, HCL Foundation, puts it, "HCL Grant is a unique initiative in the CSR space where we recognize the heroes contributing to the growth and development of India, and also engage with them over a period to achieve a significant impact within the society. At HCL Foundation, it has been our continuous focus to strengthen and support the rise of the Fifth State - the NGO ecosystem. It is a step towards re-establishing the cycle of strong governance in civil society and providing a platform where these NGOs receive unprecedented visibility for their path-breaking work in reaching out to the marginalized, isolated, underserved, and underdeveloped rural communities of India." CRY identified, profiled each vulnerable child, and defined six vulnerable categories to develop an intervention strategy for each. The team at CRY worked on the ground to enroll vulnerable children in the Child Activity Centers (CAC) and Digital Education Centers with the consent of parents.

मध्य प्रदेश के जनजातीय क्षेत्रों में मातृ, नवजात और बाल स्वास्थ्य परिणामों में सुधार
जब मातृ नवजात और बाल स्वास्थ्य को बात आती है तो खंडोल मध्य प्रदेश का एक ऐसा जिला है जहां नवजात मृत्यु दर (एनएमआर) उच्च रहता है। प्रसवपूर्व देखभाल (एचपीसी) और जनपन को अप्रत्यक्षता के बारे में जन की भावना है जो निर्मित को बदल बना देती है। विशेषज्ञों के अनुसार केवल जन्दा पता लगाना और प्रसव और उच्च जोखिम वाले गर्भधारण अस्वस्थ और छोटे बच्चों का अच्छा प्रबंधन मातृ और नवजात मृत्यु दर को कम कर सकता है। 2003 में स्थापित डीआरए हॉल्स एक्सन ट्रेड अपने सार्वजनिक स्वास्थ्य लक्ष्यों को प्राप्त करने के लिए भारत सरकार और राज्य सरकारों के साथ मिलकर काम कर रहा है। इसका काम एचसीएल और टीबी की रोकथाम और निवारण के क्षेत्रों में प्रजनन मातृ नवजात और बाल स्वास्थ्य में महत्वपूर्ण सुधार प्रदान करने में शामिल है। नवजात पोषण और स्वास्थ्य प्रणालियों को मजबूत करने पर केन्द्रित है। खंडोल में मातृ नवजात और बाल स्वास्थ्य में सुधार परिणामों से एक परिचय प्राप्त रहा है। इस परिचय के लिए स्वास्थ्य क्षेत्रीय के लिए एचसीएल प्रॉजेंट के साथ 5 करोड़ का अनुदान मिला। भारत के सबसे बड़े और सबसे प्रतिष्ठित संस्कृत सीएसआर अनुदानों में से एक एचसीएल प्रॉजेंट गैर-सरकारी संगठनों के समुदाय के नेतृत्व वाले परिधिगतियों को उदय को मान्यता देता है। परिचय वाले स्वास्थ्य महत्वपूर्ण मातृ नवजात और बाल स्वास्थ्य (एनएमआर) नवाचारों को उल्लेखनीय गुणवत्ता और उपयोग में बढ़ावा देता है। नैतिक कि सुखी निधि पुंढीर निदेशक एचसीएल फाउंडेशन कहती हैं। समाजिक, आर्थिक रूप से असमर्थ लोगों के निर्माण को प्रोत्साहित से प्रेरित एचसीएल प्रॉजेंट पर्यावरण स्वास्थ्य और शिक्षा के क्षेत्रों में परिवर्तनकारी मॉडल और समाधानों को प्रदान करने और निर्माण करने के लिए काम करता है। यह संकल्पों से स्वास्थ्य विचारक क्षेत्रों में गैर-सरकारी संगठनों के साथ हमारे समुदाय ने अभिन्न समुदाय के नेतृत्व वाले स्वास्थ्य देखभाल समाधानों के उदय और विकास को प्रोत्साहित की है। हमने भारत के उदय के क्षेत्रों में प्राथमिक स्वास्थ्य केंद्रों को समर्थन प्रदान किया है और लोकप्रिय विकल्पों वाले लोगों को शामिल करने को दिशा में भी काम किया है। एचसीएल प्रॉजेंट एडवैन्स टु हेल्थ केन्द्रीय प्रयासों द्वारा हेल्थ एक्शन ट्रेड (आईएचएटी) के साथ हमारी साझेदारी ने हमें मातृ नवजात और बाल स्वास्थ्य परिणामों में सुधार को दिशा में अपने प्रयासों को आगे बढ़ाने में सक्षम बनाया है।

नया सीएसआर खुलासा मानदंड एक सकारात्मक कदम: एचसीएल फाउंडेशन नई दिल्ली (भाषा)।
एचसीएल फाउंडेशन की निदेशक निधि पुंढीर ने कहा है कि कंपनियों द्वारा कॉरपोरेट सामाजिक उत्तरदायित्व (सीएसआर) खर्च के लिए सरकार द्वारा अधिसूचित विस्तृत प्रकटीकरण ढांचा एक सकारात्मक कदम है, क्योंकि इससे पारदर्शिता बढ़ेगी। पुंढीर ने कहा कि हालांकि सरकार ने इस साल इसके प्रारूप को अधिसूचित किया है, लेकिन एचसीएल टेक्नोलॉजीज की सीएसआर शाखा - एचसीएल फाउंडेशन 2015-16 से ही अपने सीएसआर खर्च के विवरण का खुलासा कर रही है। उन्होंने कहा, “यह एक बहुत अच्छी बात है। यह एक बहुत ही सकारात्मक कदम है।” एचसीएल फाउंडेशन ने सीएसआर कानून को अपनाया है। पुंढीर ने कहा कि सीएसआर गतिविधियों के संचालन के लिए 10 नियमों के साथ एक नई सीएसआर नीति भी लागू की गई है। सरकार द्वारा अधिसूचित सीएसआर खर्च के नए खुलासा या प्रकटीकरण ढांचे से विशेषणमक कार्यों में मदद मिलेगी और खर्च के संबंध में अधिक पारदर्शिता आएगी। लाभप्रद कंपनियों के लिए सीएसआर व्यवस्था अप्रैल, 2014 में लागू हुई थी और 30 सितंबर, 2021 तक उपलब्ध आंकड़ों के मुताबिक चालू तिमाही के दौरान इसपर ₹8828.11 करोड़ खर्च किए जा चुके हैं।
