## Executive Summary

The HCLTech Grant Symposiums, organized by HCLFoundation and CSRBOX, have played a significant role in promoting civil society engagement and collaboration in India. By aligning these symposiums with the G20 Presidency and involving civil society organizations (CSOs) in discussions and policy coordination, HCLFoundation and CSRBOX have contributed to enhancing civil society's role in shaping the global economic agenda.

Indeed, with India holding the G20 Presidency from December 2022 to November 2023 under the theme of "Vasudhaiva Kutumbakam," emphasizing inclusive and sustainable development, there has been a notable increase in focus on addressing global challenges through collaboration and cooperation. The concept of "Vasudhaiva Kutumbakam," which translates to "One Earth | One Family | One Future," underscores the interconnectedness of nations and the shared responsibility to work together for the betterment of the planet and its inhabitants.

The symposiums provided a platform for CSOs to learn, share knowledge, and leverage their expertise in addressing key challenges related to sustainable development, economic stability, and financial governance. The discussions covered a wide range of topics, including poverty alleviation, sustainable economic growth, health, unemployment, and climate change. By bringing together industry leaders, experts, and CSO representatives, the symposiums fostered dialogue, collaboration, and advocacy on these critical issues.

Overall, the 9th edition of the HCLTech Grant Symposium had a total of 1990 active participants, including 1867 NGOs from various locations. The series featured 75+ speakers from various backgrounds, including government departments, consultants, and CSR activists. These speakers shared their insights and expertise, contributing to the knowledge exchange and discussions during the event.

### About HCLTech Grant

The HCLTech Grant, with its three thematic categories of Environment, Health, and Education, offers NGOs a significant opportunity to implement path-breaking models of rural development. The grant provides a substantial amount of ₹ 5 Crore (~US\$0.65 million) to the winning NGOs in each category for a 4-year project. Additionally, the 2 other finalists in each category receive ₹ 25 lakhs (~US\$0.03 million) for a year-long project.


### Symposiums Journey - 9th Edition:



### Modes of Outreach



The HCLTech Grant Symposium undertook an extensive and structured outreach process to ensure the circulation of information to as many NGOs as possible, regardless of their scale. The outreach efforts were designed to foster curiosity, sustained engagement, and opportunities for dialogue with NGOs, encouraging their active participation in the symposiums. This process commenced around one month prior to the scheduled start of the symposiums, with the aim of generating momentum and generating interest in the event.

To reach out to NGOs, various platforms such as emails, WhatsApp messages, calls, SMS, and social media were used. These channels provided diverse avenues for communication, allowing the organizers to connect with NGOs in different ways and accommodate their preferred modes of communication.

Emails were widely used to send detailed information about the symposium, including the event schedule, topics of discussion, and registration details. This allowed NGOs to have a comprehensive understanding of the symposium and decide whether they would like to participate.

WhatsApp messages, calls, and SMS were extensively used for more direct and personalized outreach. These channels were employed to establish one-on-one communication with specific NGOs, providing them with a more personalized invitation and addressing any queries they may have had.

Social media platforms played a crucial role in creating consistent engagement. The various social media platforms were leveraged to generate excitement, share updates about the symposium, and highlight the benefits of participation. The social media channels such as Facebook, Twitter, LinkedIn, and Instagram were used to reach a wider audience and engage with NGOs on a broader scale. This approach allowed for ongoing communication, as NGOs could follow the symposium's social media accounts for regular updates and engage in discussions related to the event.

**Dr. Nidhi Pundhir, Vice President, Global CSR, HCLFoundation**, provided an engaging context for the day and a comprehensive brief on the transition from HCL Grant to HCLTech Grant, ways the grant has adapted to a changing legal landscape, HCLTech grant priorities aligning with the G20 agenda, and promoting Vocal for local with E-Haat.

The session was typically divided into two parts and was broken into an interactive dialogue for higher comprehension of NGOs from remoter geographies:

- **Green Growth and Sustainable Change**

  - CSR as a catalyst for driving beneficial environmental effect through: expertise, collaborations and resource leveraging
  - Creating greener future and meeting sustainability goals by adapting to sustainable practises, innovation, and teamwork
- **Qualifications of a Company for CSR:**
  - Importance of company's CSR qualifications as a critical factor for successful governance and accountability in CSR efforts
  - understanding the role of the board of directors and CSR committees in implementing successful CSR policies
- **Other Key Take Aways**

#### Part B: Impact and way forward for NGOs in relation with CSR

- **Corporate Board Room Narratives to Grassroot Impacts:**
  - The discussion began with narratives, pragmatic experiences, the evolution of CSR, and the new era of impact delivery, all of which show the growing emphasis on community impact and CSR in corporate boardrooms.

- As corporations invest major cash towards CSR programmes, it is critical for NGOs to synchronise their strategy in order to successfully traverse the shifting terrain.
- **Key strategies for NGOs include:**
- **Defining a Core Area of Expertise:**
  - By establishing their core area of competence, non-governmental organisations (NGOs) can focus their resources and efforts on specific issues.
  - It is also critical to maximise the impact factor and successfully satisfy the requirements of the communities they serve.
- **Prioritising Impact Delivery:**
  - Ensuring that activities and initiatives are well-planned, evidence-based, and focused on achieving meaningful and long-term change.
  - Proper effect evaluation and reporting must be developed in order to gain credibility and obtain additional financing.
- **Planning for Visibility:**
  - In order to attract funders, raising creative awareness about work, and establishing a positive brand image, NGOs should use efficient communication and marketing methods.
  - Sharing success stories and testimonials from recipients can assist to increase their credibility.
- **Collaboration with Government:**
  - Collaborating with government agencies and officials can result in systemic change and provide non-governmental organisations (NGOs) with additional resources, expertise, and support.
  - By involving lawmakers, they can help shape rules and regulations that promote their cause.
- **Social Stock Exchange:**
  - Recognising the concept of a Social Stock Exchange, which enables businesses to raise financing from major institutional investors.
  - Ways The HCLTech Grant assists in becoming acquainted with the minimal disclosure criteria for listing on the Social Stock Exchange, as well as comprehending vision, objectives, strategy, governance, management, operations, finance, compliance, credibility, social effect, and risks.
- **Mindset of Openness and Collaboration:**
  - The need for an open and collaborative approach to collaboration with other NGOs, corporations, universities, and community leaders. This technique promotes the exchange of knowledge, collaborative activities, and group problem-solving.

### Key Takeaways from the Panel Discussion

- **Measurability and Scaling**
  - The panellists stressed the need of matching project impact with acknowledged metrics.
  - The need for scaling local ideas and concepts at the global level
  - The importance of Implementing comprehensive Management Information Systems (MIS) as a critical tool

**It was emphasized that these factors can also help in fostering trust, recruiting funds, and maximising the overall effect of Poverty Alleviation (SDG Goal No.1) activities, making it more organised and effective.**
- **Collaboration and Technology**
  - The Karnataka State Government's Akansha initiative, a technology-based initiative collaborating NGOs and corporations was discussed. Such platforms can facilitate effective communication, resource sharing, and knowledge, best practises dissemination and organisations reaching to more people and have a strong impact.

**Thus, it was highlighted that non-governmental organisations (NGOs) play an essential role in contributing to Sustainable Development Goal 1 (SDG 1) and other interconnected goals through collaboration with numerous stakeholders.**
- **Gender Equality and Sustainability**
  - Women's empowerment through access to education, healthcare, financial services, and job opportunities can break the cycle of poverty and enhance community well-being.
  - Alleviation initiatives must prioritize gender-inclusive interventions for sustainable and inclusive development.



- HCL's pledge to achieve carbon neutrality by 2040 was brought to the forefront to show how to include sustainability in poverty alleviation strategies.  
**According to the panellists, the G20's recognition of women's essential role in growth, as well as many corporations' preference for women-led organisations, emphasize the need of empowering women in poverty reduction activities.**
- **Intersection of Environmental, Social, and Governance (ESG) and Corporate Social Responsibility (CSR)**
  - Addressing ESG through CSR is crucial for sustainable development, and including ESG factors in poverty alleviation efforts will ensure social responsibility and ecological sustainability.
  - Tailored proposals aligning with ESG and CSR have higher acceptance and implementation rates, and integrating ESG into companies' strategy, should be transparent and emphasize positive social and environmental impacts.  
**The C20 initiatives align with SDG No.1 and support the G20's goal of inclusive and sustainable growth. They can: increase impact, generate sustainable development, foster collaborations and power women as agents of change.**

### Session: HCLTech Grant Process, Experience Sharing and Grant Help Desk

The session's purpose was to familiarize NGOs with the application process for the HCLTech Grant. The speakers included previous grant winners and finalists, as well as subject matter experts from the HCLFoundation. 

#### ▪ Evaluation Parameters for HCLTech Grant:

The evaluation process for the HCLTech Grant considers the organizational strength, capacity to deliver, and governance structure of NGOs at the organizational level. At the project level, the evaluation focuses on relevance, impact/innovation, sustainability, inclusiveness, replicability/scalability, and financial modelling. This comprehensive evaluation ensures the selection of NGOs with strong capabilities, innovative proposals, and a commitment to sustainability and inclusiveness.



### Key Takeaways from the Panellists Session

During the session, experts/panellists shared their experiences and insights regarding the HCLTech Grant process. Here are the key pointers highlighted by each speaker:

- **Dr. Shafia Wani** emphasized the importance of a well-defined proposal, focusing on the theory of change and the organization's capacity to implement the project effectively.



- **Mr. Santanu Chakraborty** highlighted the strong and reliable mechanism of the HCLFoundation, mentioning the systematic evaluation process that ensures transparency and fairness. He also discussed the positive impact his organization achieved with the support of the grant.
- **Mr. Amitava Roy** stressed the importance of impact rather than geographical reach for organizations. He shared how the grant journey served as a valuable learning experience, enabling his organization to improve beneficiary management systems and internal processes and leverage technologies.
- **Dr. Santosh George** mentioned that although his organization did not receive financial support through the grant, the experience had a positive impact on their team. It served as a capacity-building opportunity, leading to improvements in their internal systems, financial management, and management information systems (MIS).
- **Mr. Rohit Bahadur** highlighted the evaluation process and provided advice for NGOs when submitting a proposal. He emphasized the significance of compliance documents, governance processes, and the clarity of the proposal.
