Under this, HCLFoundation is committed towards conservation of environment and the indigenous flora and fauna; with the primary objective to conserve, restore and enhance local ecosystems and respond to climate change in a sustainable manner through community engagement.

Background - The Environmental Complex

We are interdependent and share the same environment. The pressing issues such as Environmental Degradation and Climate Change are complex, boundary agnostic and are triggered by different drivers; exacerbating environmental risks and leading to deteriorating quality of life and human health. Many a times issues that seem local would require a landscape approach to deal with. World leaders have identified education as a key solution towards sustainable development of countries; as creating a strong link between the environment and the quality of human life is crucial to ensure conservation of environment and natural resources.

Against this context, the 'Harit' programme(Harit, henceforth) is aimed towards restoring the environmental balance; with the primary objective to conserve, restore and enhance



indigenous ecosystems and its services and respond to climate change in a sustainable manner through community engagement. Throughout the process, Harit focuses at building scalable and replicable models that are economically viable, socially acceptable, environmentally sustainable, holistic and inclusive.

An integrated and strategic broader-scale approach to environmental action and conservation enables to bring in stakeholders and partners together to work on a common and shared environment and deal better with both the site-level and wider landscape needs. This will also enable us to better understand feedback of the interventions, optimize resources and prioritize actions.

Key Intervention Areas

All these interventions under Harit follow a 'Participatory and Convergent Approach' in attaining the desired results towards Sustainable Developmental Goals aligned to the National Indicator Framework for SDG.

Operational in nine States - Uttar Pradesh, Tamil Nadu, Karnataka, Maharashtra, Andhra Pradesh, Odisha, West Bengal, Uttarakhand, Telangana, Harit is building sustainable and inclusive models towards:

- Increase in green cover, carbon sequestration, native biodiversity through afforestation and habitat improvement
- Conservation and rejuvenation of waterbodies through community engagement
- Reduction in CO₂ emissions
- Improvement of Coastal and Marine Habitats for native biodiversity
- Improving lives of stray animals and addressing human animal conflict inside community areas
- Enhancing environment awareness among communities by environment education with the help of innovative tools and techniques

Achievement

Till now, HCLFoundation has planted 700,000+ saplings on 310+ acres area across India, with more than 90% survival rate. Around 110+ waterbodies are being rejuvenated with an increased water holding capacity of 5,000+ Mn Litres. Through the afforestation and carbon reduction initiatives, we have been able to sequester/ reduce emission to 1500+ tons of CO_2e , along with that 91+ tons of stubble were stopped from being burnt. We worked towards improvement of coastal habitats planting more than 6,00,000+ Mangrove and Shelter belt saplings and around



1,00,000+ Kgs of ghost nets were retrieved from coastal waters. We have been able to treat 65,000+ domestic animals and around 3,500+ wild animals through our Animal Welfare vertical. Through our outreach and environment education programme we have been able to reach out to 15,000+ people pan India.
